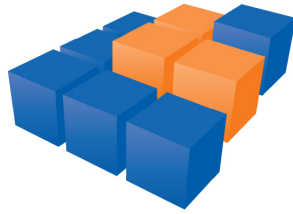
We have recently installed our latest update to the system and I'm pleased with the continual development of the software.
